A 2-DAYS UNDERGRADUATE STUDENT
COMPETITION ORGANISED BY ITLL

WHAT IS IT?

ITLL Student Challenge is a sort of “Legal Hackathon”, during which students will be asked to solve a complex Business/Tech Law problem that might arise in an everyday law practice. Divided into Teams, each supported by a Mentor (young practitioners), participants will have one day and half to hack the solution.

Teams will then be asked to present it before a panel of Judges consisting of Professors and Practitioners coming from Top Law Firms.

Challenge participants will be evaluated on their research, analysis, persuasiveness, and oral/writing ability.

The language is Italian.

The Student Challenge is part of the Course in IP & Technology Law (Prof. Claudia Sandei) and contributes to the “Innovative Teaching Project” sponsored by UNIPD.

WHO CAN ENTER?

The Student Challenge is opened to all law students resident in Veneto (Italy). There are a limited number of spots available for this event (cap of 5 Teams).

WHY SHOULD YOU ENTER?

- If you are interested or curious about Technology Law and Business.
- If you're looking to expand your knowledge, experience and network in a new exciting area of Law.
- If you are searching for graduate opportunities including training contracts, etc.



FURTHER EVENT FAQs

1. Do I need to be an expert or have any special knowledge?

No, you don't need to have any particular experience to participate. There will be Mentors on hand to offer guidance and tips during the challenge.

2. Is the event only open to students?

Yes, to ensure a level-playing field, all entrants should be enrolled as students at the time of the competition.

3. What should I bring with me?

Please bring a laptop or tablet so you can look things up on the day and write up and submit your challenge answers. There will be free wifi available at the Venue.

4. Who are the Mentors/Judges?

A full list of Mentors/Judges will be confirmed in due course.

5. How are Teams Formed?

Each Team will have 3-5 members and 1 Mentor. Teams are formed by the Organizers and will be communicated at the kick-off meeting.

6. What will be provided during the contest?

Free wi-fi access. Two-day beverages. Mentors for groups.

7. How much does it cost?

Admission is free but registration is required.
